## Liberty Steel makes two senior appointments to drive the European business forwards

Liberty Steel Continental Europe, part of Sanjeev Gupta's GFG Alliance, today announces that Pascal Genest is joining the company on 1 December 2019 as CEO of Liberty Ostrava, the largest fully integrated steel plant in the Czech Republic with more than three million tons of production capacity. He has also worked in senior roles in the aluminium and Private Equity sectors.

Ashok's new role will see him take leadership of the finance function across the Liberty Steel Continental European organisation as well as acting as a business partner to its CEO Jon Bolton and the wider commercial organisation, driving business development. Ashok has a wealth of experience in the steel sector having served in senior operational and finance roles in countries across Europe.

Jon Bolton, CEO of Liberty Steel Continental Europe said: "We are very pleased to welcome Pascal to Ostrava at such a critical point in the plant's development. Like us he is looking forward to returning it to its preeminent position in the region and I believe his leadership experience and deep knowledge of the global steel sector will help us get there. I'm also looking forward to working even closer with Ashok as he steps up into his new, more strategic role."

Pascal Genest said: "I am very excited at the opportunity ahead of us at Ostrava and working with the strong team Ashok has put in place and with all the stakeholders to deliver the plant's long term, sustainable bright future."

Ashok Patil said: "I have thoroughly enjoyed my time in the leadership at the Ostrava steelworks and have full confidence that the management team I leave behind will be massively supportive to Pascal as he looks to take the plant onwards."
